



School Fee Resolution for 2024 academic year:

In accordance with the regulations as laid down in the South African Schools' Act of 1996, a meeting of parents was held on 31 October 2023. At this meeting the proposed budget for 2024 was accepted and an adjustment to the current school fee of R220.00 per month was accepted. Compulsory school fees for 2024 in terms of Section 39 of the South African Schools Act, will therefore be as follows:

Compulsory school fees for 2024 Grade 00 – 7 R 23 100.00 per annum, per child

School fees are payable in advance and are due on the first day of the school year 2024

The following **TERMS OF PAYMENT** are offered by the school:

Please note that the following resolutions are in place:

Resolution 1: We, the parents of Erica Girls' Primary School, resolve to be a fee-paying school. School fees will be determined for 2024 and charged by the school.

Resolution 2: We, the parents of Erica Girls' Primary School, approve the budget for 2024, as tabled, which reflects the estimated trends of non-payment and the exemptions likely to be granted to parents in terms of applicable legislations.

Resolution 3: We, the parents of Erica Girls' Primary School, agree to apply total, partial or conditional exemption of parents who are unable to pay compulsory school fees as specified in the Regulations for the Exemption of Parents from the Payment of School Fees, 2005, as amended.

Resolution 4: We, the parents of Erica Girls' Primary School, authorize the School Governing Body to make payments to state employed members of staff in terms of Section 38A of the South Africa Schools Act as reflected in the budget tabled.

Resolution 5: We, the parents of Erica Girls' Primary School, agree that the school fees for 2024 will be as follows:

- Compulsory school fees for 2024 Grade 00 – 7 **R 23 100.00 per annum, per child**

Very Important:

- School fees are a statutory obligation. Parents irrespective of their marital status and/or personal arrangements (married, divorced or unmarried) are jointly and severally liable in law for their school fees.
- Should parents' default on any one month's payment, **the FULL school fee amount will become due and payable immediately.**
- Accounts of parents who default on payment will, without exception, be handed over to our attorneys for collection. Judgement could be taken against either or both parents, for the principal debt with costs, which would result in your being blacklisted.
- Kindly note that this letter serves as a notice in terms of Section 41(5)(a) of the South African Schools Act 84 of 1996. You are entitled to apply for a reduction, alternatively exemption from school fees, in which event you are to indicate your intention to apply and whether you require assistance with such application. Applicants must be prepared for an exhaustive investigation, supported by documentary proof, into their financial circumstances and lifestyle. This is an annual application to the SGB which needs to be completed by the end of February 2024. The income of both parents irrespective of their marital status or maintenance agreement are used in calculation of exemption.
- Exemptions are funded from the school fees paid by other parents. The Department of Education is not forthcoming in assisting the school financially as is communicated by them.
